1. INTRODUCTION

Strengthening and enforcing legal frameworks that protect women's rights, coupled with advocacy for legal reforms, and their full and meaningful participation in the electoral process are crucial. Furthermore, healthcare disparities can be alleviated through the expansion of healthcare infrastructure, women's health education, and community health initiatives. Building a gender-just society in Pakistan demands a concerted effort from the government, civil society, and the private sector. By addressing these constraints and promoting gender justice, the nation can unlock the future potential of its human resources, ensuring a more equitable and sustainable future.

In pursuit of HRDN's mission to steer positive change and social impact, the 24th All Members' Meeting in 2023 focused on the overarching theme of "Continued Actions for Promoting Gender Justice in Pakistan." This strategic choice not only aligned with the ongoing global discourse on gender equality but also underscored HRDN's pivotal role as a catalyst for

transformative initiatives.

The event, hosted on December 28, 2023, at Hotel Marriott, Islamabad (refer to the attached agenda in Annex 1), drew the participation of approximately 50 professionals from various sectors, including public and private organizations, the development sector, UN agencies, and media outlets. 2.2. WELCOME ADDRESS

Moreover, he emphasized that equitable access to healthcare and education, fundamental tenets of gender justice, has a far-reaching impact, positively influencing families, communities, and the nation as a whole. Dr. Hayat affirmed that a gender-just society is not only an ethical

3. DELIBERATIONS:

3.1. The Panelists Ms. Fajar Pasha SAPM to Education Ministry, Mr. Ali Kemal Chief SDG Unit MoPD & SI, Mr. Ali Reza CEO Peace& Justice Network (PJN), deliberated on the study findings' "Unpaid Care Work and Women



Empowerment." "conducted by Dr. Shela on "Women Contribution in Care Economy". The panelists highlighted the significance of recognizing unpaid care work that extends beyond its inherent value. It serves as a crucial linchpin in efforts to mitigate gender-based violence and curb early child marriages. Beyond these societal benefits, connecting this

acknowledgment with the implementation of robust social protection measures adds a layer of practicality to the discourse. Investigating further, understanding the profound impact of unpaid care work on women's dignity and economic empowerment becomes a cornerstone for shaping meaningful research and policy initiatives. By weaving together these threads, we not only underscore the importance of unpaid care work but also lay the groundwork for holistic and impactful societal change.

Mr. Ali Kemal Chief SDG acknowledged the efforts contributing to Sustainable Development Goal (SDG) Target 5.4, promising to "recognize and value unpaid care and domestic work." This commitment involves deploying public services, improving infrastructure, and implementing social protection policies. The overarching objective is to not just acknowledge these contributions but actively promote shared responsibility within households and families, tailored to each nation's context. This signifies a shift towards an equitable societal structure that values unpaid care work as integral to sustainable development.



3.2. The deliberations on "Catalyzing Change, Fostering Fairness, And Elevating Equality Beyond Barriers" was chaired by Mr. Zafrullah Khan CEO Vision 2047, a renowned journalist and civic educator along with Senator Ms. Fauzai Arshad and Senator Mr. Waleed Igbal. During the discussion, the panelists shared their insights and comments, emphasizing the critical necessity to enhance women's participation in political and social spheres in Pakistan. They highlighted various issues and proposed potential solutions to foster inclusivity and equality. Pakistan's current ranking at 176th out of 181 countries in the Gender Development Index, reflects the substantial hurdles faced by women in the nation. This emphasizes the urgent need for comprehensive initiatives to address gender disparities, enhance Pakistan's global standing, and promote gender parity across all sectors. The overarching objective is to establish an environment where women actively



contribute to the nation's progress.

The study conducted under Mr. Zulqranain meticulously dissects societal, institutional, and structural barriers impeding women's social and political participation. By unraveling these challenges, the study aims to unveil strategies and proposals fostering women's political empowerment, ultimately steering towards a more inclusive political landscape in Pakistan.



4.1 CLOSING OF EVENT
